NEW BUSINESS

Review Ordinance No. 1391/City Assuming Zillah TBD: Ms. Bounds explained that a public hearing will be held during the Council meeting and proper advertising has been done. There was a change made to the ordinance relating to the effective dates of the city assumption. The dates were changed from "as of the effective date of the ordinance" to January 1, 2016. That allows the TBD to finish out the year and the city to begin at the beginning of the year.

Review Ordinance No. 1392 Establishing Special Revenue Fund for Zillah TBD: Ms. Bounds explained that this fund was created for the purpose of using it for the TBD funds within the city accounts.

<u>Review Ordinance No. 1393/2015 Budget Amendment:</u> Ms. Bounds provided detailed information related to the budget amendments.

Review Resolution No. 2015-50 Approving Contract for Professional Services: Ms. Bounds explained that the current judge has a scheduling conflict on one of the court dates in December so Susan Arb is being contracted to cover for that date.

Review Resolution No. 2015-51 Approving Contract with McKinney Commercial Glass & Door: Ms. Bounds explained that the city recently solicited bids for the ADA door improvements for city hall and the police department. McKinney Commercial Glass & Door came in as the low bidder and the attached contract is for those services to occur.

<u>Review Ordinance No. 1394/Franchise with LS Networks, Inc.</u> Ms. Steele provided information about the amendment to this ordinance. It includes adding additional coverage area to their map.

Review Ordinance No. 1395 Establishing Garbage Collection Rates. Ms. Bounds explained that the Mayor along with the Budget/Finance Committee met to review the request from Yakima Waste. They are recommending the city grant a 1.5% (pass through) increase for 2016 only. The attached ordinance reflects that rate change. Keith Kovalenko from Yakima Waste was present and also provided information on their request. He also mentioned that the city might consider the same kind of deal they just entered into with Mabton which was a 1-3% increase each year.

<u>Review Resolution No. 2015-52 Approving Agreement with Yakima Waste:</u> This is the agreement between the City of Zillah and Yakima Waste approving the aforementioned rate increase for 2016.

Review Ordinance No. 1396 Reducing Utility Tax Charges for Water: Ms. Bounds explained that the water rates were increased over a 7 year period starting last year and it was decided at that time that the utility tax for water could be decreased a portion of that time, as well.

Review Ordinance No. 1397 Establishing Cemetery Fees: Ms. Bounds explained that staff recently gathered comparables for the cemetery fees and found Zillah to be low. The Finance/Budget Committee met and reviewed them and are recommending that the fees be increased to be comparable with those other cemeteries.

Review Ordinance No. 1398/Buildings and Construction: Ms. Steele explained that changes to the Ordinance include exempting fees for residential fences and adding a flat penalty fee for those not getting a permit for fences when needed.

<u>Review Resolution No. 2015-53 Approving Administration Policy No. 2015-01:</u> Ms. Gonzales pointed out an error in the policy and Ms. Bounds stated that it would be corrected and brought back to a future meeting.

Review Restricted Fund Uses: Ms. Bounds explained that the 2016 Final Budget Summary Packet contains information related to all of the budget, restricted fund usage, cost allocation plans, etc. All of the information contained within the packet has been reviewed and discussed during the budget process and a motion needs to be made to specifically address adoption of the packet.

Review Ordinance No. 1399 Adopting the 2016 Budget: Ms. Bounds explained that this ordinance approves the 2016 Final Budget.

Review Amended Street Closure Request: Ms. Bounds explained that Zillah Chamber recently realized there was a scheduling conflict at the Civic Center for the Old Fashioned Christmas event. They decided to move the event downtown from 2-5 p.m. and are requesting street closure during those hours rather than 4-5 as previously requested. Beth Husted provided information related to the event and answered questions.

COUNCIL/STAFF REPORTS

<u>Planning:</u> Ms. Steele explained that a transportation bill was recently approved. It will provide funding through 2020 which includes the funding for Zillah. She will gather further details at a meeting she attends on Thursday.

<u>City Toy Drive</u>: Chief Simmons invited everyone to participate in the City Toy Drive by bringing toys to designated locations by December 18th for children ages 2-13. City Staff will deliver the items on Saturday, December 19th.

<u>Demolition:</u> Mr. Tilley reported that the city house will be demolished this week. The necessary permits will be collected prior to demolition.
