NEW BUSINESS

Review Resolution No. 2016-13/Contract Amendment with DOL: Ms Bounds explained that the state now contracts with DOL instead of DOR to manage the Transportation Benefit Districts. The contract has changed to reflect that as well as changes that the legislation made allowing cities to assume the rights, obligations, powers, etc. of the TBD's.

Review List of Committee Assignments: Changes to this were to add "City Theme Design & Regulation Committee" to the list. Ms. Bounds explained that she will work with this committee to bring forward, new projects in the city that incorporate the theme. The hope is to generate new enthusiasm with business owners.

Discuss Fireworks and 4th of July Activities: It was explained that the Lion's Club no longer want to run the fireworks stand which means that the 4th of July shoot will not be funded. Several options were discussed and more ideas will be brought back for further review.

COUNCIL/STAFF REPORTS

Planning: Ms. Steele shared that the VERG group gave a presentation at the last YVCOG meeting. They used their VERG system to model the proposed road through Vintage Valley. It was quite impressive.

Public Works: Mr. Tilley reported that SVID will be releasing water into the canals this week so it should be available next week or by 4/1. He said that the batch plants should be opening up this week so that the crew can get busy filling in the potholes throughout town. He also shared that they have recently finished working on a drain on 5th Street.

Administration: Ms. Bounds mentioned that the county will be releasing funds to cities for free dumping at the waste disposal site. Discussion was held about Zillah holding a free dump day. Ms. Bounds said that staff is waiting for further information from the county so that plans can be made.
